## Platinum Coaching Participation Agreement, Terms and Conditions

By enrolling and purchasing this coaching membership online, I agree to the following terms. Please enroll me as a customer in the Platinum Coaching Member program (hereinafter referred to as "PCM") with Six Figure Business Coach, a DBA of Six Figure Real Estate Coach, Inc. (hereinafter referred to as "SFREC"). PCM membership includes the following: one (1) two-hour one-on-one *PowerStart* session with Roberta; two (2) pre-scheduled 30-minute one-on-one calls per month for six months, Six (6) monthly Success Series, (6) monthly live Secret Sauce Group Coaching calls, and six (6) monthly copies of Free Yourself to Success Newsletter Express<sup>TM</sup>; Access to Online Coaching Membership Site (Beginning May, 2016). PCM understands and agrees that they will choose among the dates and times SFREC has available for their bi-monthly call slots and that any materials customer wants SFREC to review or discuss for a coaching call must be received by SFREC no less than 24 hours prior to the call via mail, fax, or email. Feedback will be provided to PCM on their next scheduled coaching call. PCM understands that the program does not include coaching emails and/or phone calls outside of the 30-minute bi-monthly calls. PCM will be provided an email address to use for administrative purposes. PCM understands that it will be their responsibility to call SFREC (number provided upon acceptance) at their scheduled times, and, unless previously arranged, any calls or time missed due to PCM missing a call or calling in late will not be rescheduled.
